European markets are now on course to rise for a third straight week, with positive momentum set in the previous month by largely better-than-expected earnings reports spilling over into November.

(Reuters) - The United Nations food agency's world price index edged slightly lower in October, the seventh consecutive monthly fall and some 14.9% down from its all-time high recorded in March.
